How do I get my document certified?

Our branch staff can copy and certify your document for you, they'll also send it on to our team in Wellington. To see if there is a branch near you, visit www.rabobank.co.nz/branch.

Alternatively, one of the following trusted referees can certify your document:

- Justice of the Peace
- Lawyer
- Member of Parliament
- Member of the Police
- NZ Honorary Consul
- Registered medical doctor
- Notary public
- Registered chartered accountant

The trusted referee must NOT be:

- yourself (i.e. you cannot certify your own documents)
- a person that is linked to your account
- related to you
- your spouse or partner, or
- a person who lives at your address.

The certified copy must:

- be dated
- state that it is a true copy of the original and represents the identity of the individual
- include the name, occupation and signature of the trusted referee, and
- be presented within 3 months of certification.
