The Nominated Account must be an account in New Zealand Dollars.

If your Nominated Account is held under a different account name to your Foreign Currency Account, or is a third-party bank account, you will need to complete an Authority to Accept Direct Debits form.

Section E: Execution and Declaration

Each Account Owner acknowledges and agrees to the following:

- 1. We are bound by Rabobank's Foreign Currency Account Terms and Conditions (found on Rabobank's website: www.rabobank.co.nz), applicable Fee Schedule(s) and all other applicable terms and conditions, as made available to us ("Terms and Conditions").
- 2. All information in this form is true, correct and complete (including information that is pre-populated by Rabobank) and we will advise Rabobank immediately if the information provided in this form changes or becomes incorrect or incomplete.
- 3. Rabobank may communicate with us by phone, email, Internet Banking or any other customary or agreed means. We must keep our nominated email address functional and regularly check to see if we have received any electronic communications from Rabobank. We must notify Rabobank immediately if we change our email address.
- 4. Each Account Owner who is an individual acknowledges that their personal information is being collected, used and disclosed in relation to the Account, including for the opening and operation of accounts with Rabobank, and that this personal information may be disclosed to entities related to Rabobank, Rabobank's contractors and relevant government authorities. We understand we can contact Rabobank on 0800 500 933 to gain access to our personal information held by the bank. Rabobank's Privacy Statement is available at www.rabobank.co.nz and contains information on how Rabobank collects and uses personal information in the course of its business, an individual's rights in respect of their personal information, and how a privacy complaint can be made.
- 5. We acknowledge that information provided about the Account Owner(s) and the Account(s) may be exchanged with the relevant tax authorities.

Signing of Authority

Individual/Sole Trader/Joint: All individuals must sign.

Company: If there are two or more directors, two directors must sign. If there is only one director, that director must sign in the presence of a witness.

Trust/Partnership: Each trustee or partner must sign in accordance with the signing rules applicable to that trust/partnership. **Limited Partnership:** The general partner must sign for and on behalf of the limited partnership, in accordance with the signing requirements applicable to the general partner (i.e. individual, company, etc).

Incorporated Society: In accordance with the Society's constitution signing rules.

By Attorney: A certified copy of the original Power of Attorney and a Certificate of Non-Revocation must be attached (only permissible with the prior written consent of Rabobank).
