I/We also authorise the Environmental Protection Authority (**EPA**) to do all things necessary to register and record the Secured Party as TPP in respect of the Account and all NZUs standing to the credit of the Account from time to time.

I/We acknowledge that by the Secured Party being recorded as TPP in respect of the Account:

1. the Secured Party or the Secured Party's representative, as the case may be, may access the Account to view the NZU balance on the Account at any time; and
2. the Account will be 'blocked' such that I/We as Account Holder, may not, without the consent of the Secured Party, transfer any NZUs out of the Account

This instruction will remain in force and effect and may not be revoked other than by written request of the Secured Party to the Environmental Protection Authority. This instruction form can be submitted to the EPA at any time at the discretion of the Secured Party.

I/We authorise the EPA to disclose to the Secured Party such information concerning the Account and the TPP as the EPA may hold from time to time. Including whether Account is subject to any TPP in favour of any third party other than the Secured Party at any time.

This form is governed by the laws of New Zealand. I/We agree this form may be executed in two or more counterparts, all of which taken together will constitute one instrument

I/We agree that neither the Secured Party and/or the EPA shall be liable for any actions taken in relation to this form, including but not limited to any acts of omission, negligence and/or recklessness except in the case of gross negligence, fraud or committed by act of wilful misconduct.

I/We acknowledge that to the extent we have any questions about this form we should seek independent professional advice including without limitation appropriate legal, financial, accounting, tax and forestry advice (as applicable).
